LIAISON REPORTS

Environmental Commission - Given by Liaison Mr. Baig

At the February 9, 2023 Environmental Commission Meeting, they discussed activities for the West Windsor Environmental Demonstration Area at Community Park, which included the planting of red cedar trees along the skate park fence, additional wildflowers for the pollinator and rain gardens, and a new Girl Scout project to add an environmentally oriented Little Free Library in an outdoor sitting area with educational native pollinator plants. This year, the Commission will take part in the County-wide Green Fest presented by the Mercer County Sustainability Coalition by holding events in West Windsor such as participating in the April 29, 2023 Arbor Day event in Rogers Arboretum put on by the Shade Tree Commission. The Commission discussed solar lighting projects including signs and larger lights for street and park areas. The Commission reviewed member Anis Baig's report on the Draft Flood Ordinance that is required by the N.J. DEP as part of an update for FEMA flood insurance requirements. The Commission voted to support the report and its endorsement of the draft ordinance proposed by Engineering pending approval by the N.J. DEP. If approved by the N.J. DEP, the draft ordinance will go to Township Council.

Affordable Housing Committee – Liaison Bahree was absent. Being a member of the Affordable Housing Committee, Councilwoman Geevers gave the report. There was no January meeting, and the Committee met on February 2, 2023. Tom Calabria was elected Chair and Jean Jacobsohn was elected Vice-Chair. The Committee voted to approve the new meeting time of 7:00 pm. They would like the Mayor to fill the vacancies on the Committee as soon as possible. The Committee will be working with Attorney Muller and Consultant Frank Piazza on a proposed ordinance for recertification of very low-income tenants who receive a \$100 per month rent subsidy. It was agreed upon that the subsidy warrants certification.

A preliminary and final major site plan application with associated design waivers, to construct a +/-5,753 SF campus operations building and related improvements such as a gravel parking area, and a gravel/reinforced turf access drive (the "Project"). This building will support the University's nursery operations and grounds maintenance. The Project also involves the removal of an existing gravel parking area and existing sheds. The Project site is located on the Princeton University Lake Campus, near the intersection of Nursery Road and Lower Harrison Street in West Windsor Township.

Attorney Muller confirmed that the proof of publication and service are in order and the Board has jurisdiction.

In regard to the projected Harrison Street realignment, she asked where the access to the Nursery would be to New/Lower Harrison Street. Attorney DeGrezia responded it was designed that the driveway entrance into the site would be extended to the road. Ms. Wormtoney also asked where the stormwater will go if the road is built. Attorney DeGrezia responded it would be continued under the road.
