Update From Health Officer

Ms. Swanson reviewed the status of the proposed changes to Chapter 140 "Smoking and Use of Tobacco Products Banned" and noted changes made to the Ordinance per the recommendation from the Board of Health at the August 8, 2022 Board of Health Meeting to include: adding cannabis to the definition of smoking; including exemptions for medical necessity; clarifying the enforcement section to include immediate summons issued in cases when the property management facility fails to provide notice of the policy to tenants and owners; stipulating the number of days to abate violations; and adding the definition of 'person';

Discussion ensued between Ms. Swanson and Council on violation penalties.

Ms. Swanson noted the following Rabies Clinic dates: November 21, 2022 at the Princeton Junction Firehouse; December 6, 2022 at the Hightstown First Aid Squad; and January 10, 2022 at the Robbinsville Public Works Facility.


Ms. Swanson noted the following COVID-19 Clinic dates: December 1, 2022 at Congregation Beth Chaim; December 7, 2022 at the West Windsor Plainsboro Board of Education Office; and December 1, 2022 at the Cure Arena.


Ms. Swanson encouraged residents to attend the clinics as needed and to refer to the State of New Jersey website and CDC website for more information.

Ms. Swanson reminded residents to practice preventative practices such as staying home when feeling sick, covering mouth when coughing, sanitizing surfaces frequently, and hand washing.
